### How did the Fund perform during the reporting period?


- From its inception on February 7, 2025, through December 31, 2025, the Fund returned more than the benchmark index it tracks, largely because the Fund remained fully invested, and therefore had less of a cash drag.
- The first part of 2025 was marked by volatility in the financial markets amid fears that U.S. tariff announcements might spark trade wars and drag down global growth. Despite these concerns, markets posted solid gains for the year, buoyed by optimism surrounding artificial intelligence, robust corporate earnings, and a more dovish monetary policy. Over the full year, the European Central Bank and the Bank of England each cut interest rates four times, while the Federal Reserve lowered rates three times.
- Amid central bank easing, the yield of the 3-month U.S. Treasury bill fell from 4.31% at the start of 2025 to 3.63% at the end. The decline in the yield of the bellwether 10-year U.S. Treasury note was a little more modest—it fell from 4.57% to 4.17% over the same period.

### How did the Fund perform since inception?
