Vanguard Diversified All Growth Index ETF seeks to track the weighted average return of the various indices of the Underlying Funds in which it invests, in proportion to the Strategic Asset Allocation, before taking into account fees, expenses and tax.

ETF overview

The ETF provides low-cost access to a range of sector funds, offering broad diversification across a blend of equity markets. The ETF invests solely in growth assets, and is designed for investors with a very high tolerance for risk who are seeking long-term capital growth. The ETF targets a 100% allocation to growth asset classes.
