We have set out the costs and charges information relating to Vanguard funds in this document in order that Investors who may not have used an Intermediary and others can have access to it.

The presentation and allocation that we have applied follow the MiFID II Regulations (Annex II of the Commission Delegated Regulation (EU) 2017/653). We have calculated the transaction costs using the methodology, "Transaction cost methodology" as defined within the EU regulations (Commission Delegated Regulation (EU) 2021/2268).

- **Ongoing charges figures:** The ongoing charges figure (OCF) covers management fees and service costs such as administration, audit, depositary, legal, registration and regulatory expenses incurred in respect of the funds.
- **Ongoing costs**¹: All ongoing costs and charges related to the management of the fund that are deducted from the value of the fund. This includes OCF, overdraft fees and securities lending fees. (Please note that when rounded to 2 decimal places, Ongoing costs less than 0.01% will be displayed as 0.00%). Please note that the reference data point for "Ongoing costs" figure in this document is EMT.
- One-off costs: All costs and charges paid to fund providers at the beginning or at the end of the investment in the fund. This includes front-loaded management fee, structuring fee and distribution fee. Vanguard does not currently have any one-off costs.
- **Transaction costs:** All costs and charges incurred as a result of the acquisition and disposal of underlying investments within the fund. This includes broker commissions, entry and exit charges, spreads, stamp duty, transactions tax and foreign exchange costs. (Please note that when rounded to 2 decimal places, transaction costs less than 0.01% will be displayed as 0.00%).
- **5 Incidental costs:** Performance fees and anything similar. Vanguard funds have no incidental costs currently.
- **6 Total fund costs:** This is the total of the ongoing costs, one-off costs, transaction costs and incidental costs of investing in the fund.


